

RULE 4 - REGISTRATION OF WATER WELLS

E. Open Loop Geothermal recovery wells.

RULE 6.A - ANNEXATION INTO DISTRICT BOUNDARIES

Annexed water wells are exempt from subject to permitting requirements, spacing, and production limitations in the District's rules.

RULE 6.B - ANNEXATION INTO DISTRICT BOUNDARIES

Export of water outside the District from annexed water wells that serve as public water utility supply wells shall be limited to 5,000 acre feet of water per year in the aggregate and shall pay an export fee of 2.5 cents per thousand gallons of water exported outside the District's boundaries. Permittees shall submit reports to the District on a monthly basis. Monthly reports are due in the District office by the 30th day of the following month. Monthly fees are due in the District office by the 30th day of the following month.

Rule 10.B APPLICATION FOR DRILLING AND OPERATING PERMITS.

An application for a drilling permit or a permit amendment is subject to spacing and production limitations relative to any approved or pending permit or existing registered exempt wells.

Rule 10.D.11 APPLICATION FOR DRILLING AND OPERATING PERMITS

The name and address of all existing, and registered exempt and permitted well owners within one-half mile of the proposed water well as shown in the records of the District;

In order to ensure no unreasonable effects on existing groundwater and surface water resources or existing permit holders, the District shall require a mitigation plan, acceptable

to the District, to be included in the application to mitigate the effects of the drawdown of artesian pressure or the level of the water table upon the registered <u>exempt</u> or permitted well owners potentially affected by that water well or wells. The mitigation plan, at permit issuance, shall be incorporated into a binding agreement between the permittee and the District. The plan shall include but not be limited to:

Rule 10.E.3.a APPLICATION FOR DRILLING AND OPERATING PERMITS

a. The actions and procedures to be taken by the holder of the drilling and operating permit in the event that pumping causes the water level in a registered <u>exempt</u> or permitted well to drop to an unacceptable level.

Rule 10.E.3.b APPLICATION FOR DRILLING AND OPERATING PERMITS

The actions and procedures to be taken by the holder of the drilling and operating permit in the event that the pumping from the permitted well causes the water to become objectionable or renders the water unusable to a registered exempt_or permitted well owner.

Rule 10.E.3.c APPLICATION FOR DRILLING AND OPERATING PERMITS

The actions and procedures to be taken by the holder of the drilling and operating permit in the event that pumping causes the well casing or equipment to be damaged so that the recorded quality or quantity of water cannot be produced by the registered exempt or permitted well owner.

RULE 11A.4 – ISSUANCE OF DRILLING AND OPERATING PERMITS

The proposed use of water unreasonably affects existing groundwater or surface water resources or existing Permit Holders, and registered exempt wells.

RULE 15.D.2 – EXPORTATION OF GROUNDWATER FROM THE DISTRICT

The projected effect of the proposed transfer on aquifer conditions, depletion, subsidence, or effects on existing permit holders, registered exempt wells, or other groundwater users within the District; and

RULE 27.B ENFORCEMENT OF RULES

The Board by rule may set reasonable civil penalties for breach of any rule of the District not to exceed \$10,00025,000 per day per violation, and each day of a continuing violation constitutes a separate violation in accordance with Chapter 36.102 of the Texas Water Code. (See Appendix A).

RULE 27.F ENFORCEMENT OF RULES

Permitted transportation facilities which fail to comply with these rules may be subject to a civil penalty to be determined by the Board not to exceed \$10,00025,000 per day of violation and each day of continued violation constitutes a separate violation.

RULE 28.B - GRANDFATHERED OPERATING PERMITS

An application for a grandfathered well permit is not subject to spacing and production limitations relative to any approved or pending well permit or existing registered <u>exempt</u> well.

RULE 28.G.2 - GRANDFATHERED OPERATING PERMITS

The rate and amount of withdrawal stated on the original registration form if the applicant's well, State of Texas Water Well Driller's Log, or wells were registered exempt with the District before January 1, 2009.
